Ready to use. Surface spray. **USE ONLY IN ACCORDANCE ON LABEL.**

For the control of flying insects (flies, mosquitoes) and crawling insects (cockroaches, fleas and bedbugs). Apply 1 litre of product per 20 square metres of surface or spray short bursts directly at insects.
